To maintain international peace and security, pursuant to the Foreign Exchange and Foreign Trade Act (hereinafter referred to as "Foreign Exchange Act"), regulations concerning Security Export Control is being enforced in Japan under the international framework in order for goods and information on advanced techniques not to be converted into weapons of mass destruction, etc. In compliance with this, Mie University is undertaking efforts based on the Foreign Exchange Act in terms of strict observance of the law. For this reason, we ask you to download the documents by yourself, print and fill them out with your signature and submit them to the counter of each department in which you enroll.
